## **ARRL Boxborough Convention Fox Hunt**

The Boxborough Convention organizers ask us to run the FoxBox at the convention for fox hunters. Ralph KD1SM and Stan KD1LE put the fox out both Saturday and Sunday and several hunters found the fox. The one person who found the fox both days was VK3MD. He was awarded an NVARC Coffee Mug at the Awards Ceremony. Some may remember that he did a presentation at NVARC on Radio Sport radio direction finding a while back.

### **Alzheimer's Memory Ride**

On Saturday July 24 a crew of 17 Amateur Radio Operators provided communications support for the Alzheimer's Association Massachusetts/New Hampshire Chapter 2010 Memory Ride for Alzheimer's disease research.

This was the 14<sup>th</sup> year for the event and the third year that NVARC has been asked to lead the Amateur Radio support. Our involvement began when the event moved to its current course starting in Devens.

250 bicycle riders were assisted by 125 volunteers, including 6 NVARC members. The riders raised over \$300,000 in donations. There were three routes for the cyclists: a 100 mile route, a 62 mile route, and a 25 mile route. This year the routes shared most of the same course, with two cut-offs where the shorter routes short-cut a portion of the longer routes.

The courses start and end at Devens, proceeding through many towns down through Clinton and up to Amherst, NH. The 5 pit stops were located in Berlin, Sterling, West Groton, Amherst, and Hollis NH. Thanks to NVARC members Bob AB1CV, Gary K1YTS, Larry KB1ESR, Stan KD1LE, Ralph KD1SM, and John KK1X. They were joined by Tom K1JHC, Jim KB1JKJ, Ray KB1LRL, Ross KB1MGD, Dave KB1MVN, Charlie KT1I, Mary N1RKO, John N2YHK, Barry W1HFN, Paul W1SEX, and Mark WB1ARZ.

We have already been asked to help with the 2011 Memory Ride. The date is Saturday, July 23 2011.

## **ARRL Letter**

#### Public Service: Colorado Hams Assisting Wildfire Relief Efforts

This image from NASA's Moderate Resolution Imaging Spectroradiometer (MODIS) shows the city of Boulder lying in the path of the smoke. MODIS captured this image at 12:15 p.m. local time (18:15 UTC) on September 6, 2010. The red outline corresponds with the unusually high surface temperatures associated with an active fire. A river of thick smoke flows eastward. Over the plains northeast of Denver, the smoke plume casts a shadow to the north. The MODIS is located on NASA's Terra satellite. A fire that began on Monday, September 6 in Emerson Gulch located in Four Mile Canyon --- just northwest of Boulder, Colorado --- has members of Boulder County ARES® providing communications support to the Boulder County Sheriff's Office and the American Red Cross. According to a 911 call, the fire was started when a truck collided with a large propane tank. "Amateur Radio operators are located at the Red Cross shelter set up at the University of Colorado Event Center and also at the Boulder County Emergency Operations Center," ARRL Colorado Section Manager Jeff Ryan, KORM, told the ARRL. "Amateur Radio operators are providing voice and ATV communications between forward fire units, the Incident Command post and the Emergency Operations Center, as well as voice and packet communications for the Red Cross."

#### Public Service: GAREC 2010 to Convene Next Month

The 2010 Global Amateur Radio Emergency Communications Conference (GAREC) -- supported by the ARRL, the IARU and all three IARU Regions -- is scheduled for October 11-12 in Curacao. With its theme of Learning through Practicing, this year's conference is an opportunity for emergency communicators to discuss recent events, discover technical solutions to problems and how to cooperate with professional partners. One of the highlights of the 2010 conference will be an actual EmComm exercise during the conference, exploring how information sharing across borders can be improved.

#### FCC: ARRL Goes Another Round with ReconRobotics

The Recon Scout -- manufactured and marketed by ReconRobotics -- is a remote-controlled, maneuverable surveillance robot designed for use in areas that may be too hazardous for human entry. ReconRobotics was recently granted a waiver by the FCC for the device to operate between 430-448 MHz, a portion of spectrum available to the Amateur Radio Service on a secondary basis.

As reported earlier, on August 16, ReconRobotics -manufacturers and marketers of the Recon Scout, a remote-controlled, maneuverable surveillance robot designed for use in areas that may be too hazardous for human entry - filed with the FCC an opposition to the ARRL's Petition to Deny Applications. The ARRL petition asked the FCC to deny dozens of pending Public Safety Pool license applications for the Recon Scout device, which operates in the 430-448 MHz band. On September 1, the ARRL filed its reply (see below).

#### FCC: ARRL Comments in FCC Review of CB Rules

In June the FCC opened a proceeding -- WT Docket No. 10-119 -- "to simplify, streamline, and update the Part 95 rules to reflect technological advances and

changes in the way the American public uses the various Personal Radio Services." The Citizens Band (CB) Radio Service is one of several Personal Radio Services regulated by Part 95. Three of the CB-related issues raised in the Notice of Proposed Rule Making are of interest to the Amateur Radio Service. On September 3, the ARRL filed comments limited to these issues.

#### FCC: ARRL Seeks to Protect 2304 MHz Operation

In May, as a partial implementation of its National Broadband Plan, the FCC adopted amendments to its rules for Wireless Communications Services in the 2.3 GHz band to permit mobile broadband services, in addition to fixed services, in the bands 2305-2317.5 and 2347.5-2360 MHz. The Report and Order in WT Docket No 07-293 was published in the Federal Register on August 2, 2010, triggering a 30 day window for petitions for reconsideration. On September 1 the ARRL filed a Petition for Clarification or Partial Reconsideration, asking the FCC to "clarify, or partially reconsider a single aspect" of its Report and Order.

# MARS: New Interim Chief Takes Over Air Force MARS

The Air Force Military Auxiliary Radio System (AFMARS) organization has a new interim Chief. Outgoing USAF MARS Chief Allen Eiermann, K3LSR, retired at the end of May and was replaced by Technical Sergeant Jason Sandifer. Sandifer is a systems manager stationed at the Air Force Network Integration Center (AFNIC) at Scott Air Force Base in Illinois, just outside St Louis, Missouri. AFNIC is the headquarters of the national Air Force MARS organization.

#### **ARRL Introduces First Challenge Coin**

The front of the new ARES® 75th Anniversary Challenge Coin.

This month, the ARRL and the Amateur Radio community celebrate the 75th anniversary of the Amateur Radio Emergency Service®, or ARES®. To help commemorate this milestone, the ARRL has introduced an anniversary Challenge Coin. The diestruck, 1.5 inch brass coin depicts the ARES® 75th anniversary logo in gold with red, white and blue color fill, while the reverse shows the ARRL diamond logo against a hemisphere of the world.

Around the perimeter of the ARES® logo are the words Ready, Resilient and Responsive. "These words represent the critical need that ARES® activities have provided, and will continue to provide into the future," said ARRL Emergency Preparedness and Response Manager Mike Corey, W5MPC. "The Challenge Coin honors the service of ARES® volunteers and all Amateur Radio operators who respond to the call of public service. We hope ARES® volunteers will enjoy the honor of having the first Challenge Coin issued by the ARRL."

#### On the Air: New D-STAR Repeater Now in Place in ARRL Laboratory

The ARRL Lab has installed a D-STAR (Digital Smart Technologies for Amateur Radio) repeater in the Lab at the ARRL Headquarters building. Operating with an output of 147.390 MHz, positive offset, the W1HQ D-STAR repeater is a local repeater with a modest footprint covering the Hartford-New Britain, Connecticut area. The antenna is on the roof of the Headquarters building with the repeater located in the Lab. With its gateway, the repeater is accessible to any D-STAR user on the planet. The Lab's call sign is W1INF.

"The purpose of the repeater is to better educate the Lab staff on D-STAR technology," explained ARRL Test Engineer Bob Allison, WB1GCM. "In turn, we will have the ability to handle some of our members' questions on the matter. We also intend to use this new technology when emergencies occur where D-STAR technology is deployed." With many HF radios now offering at least 6 meter SSB/CW capabilities -- and some offering 2 meters and 70 cm as well -- any amateur with a Technician class license or higher can experience long-haul communication on the VHF bands." #### FCC: New Rules for Employee Participation in Drills Begin September 3

Beginning September 3, the new, revised wording of Section 97.113 goes into effect. As of this date, the FCC will permit government entities that sponsor disaster and emergency drills to hold these drills without applying for a waiver. Additionally, employees who wish to participate in non-governmentsponsored drills and exercises may do so under certain conditions. Part 97 is the portion of the Commission's rules that govern the Amateur Radio Service. Read more here.

#### FCC: FCC Reaffirms 2×2 Call Signs Are Only for Advanced, Amateur Extra License Classes

In May 2010, John Gottschalk, KB1DDK, of Westwood, Massachusetts, requested a new call sign via the FCC's vanity call sign program. Gottschalk, a General class licensee, requested KK1CQ -- a 2×2 call sign -- and a waiver from the Commission allowing him to hold the call sign. The FCC denied both requests on Tuesday, August 31, 2010. Read more here.


